The *Carlos Hilado Memorial State College*, through the *Corporate Budget for the Contract of 2016 approved by the governing Board*, intends to apply the sum of **EIGHT HUNDRED TWENTY-SEVEN THOUSAND NINETY-EIGHT PESOS & 00/100 (Php 827,098.00) ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract for the **SUPPLY AND DELIVERY OF VARIOUS IT SUPPLIES AND CONSUMABLES FOR THE FOUR (4) CAMPUSES (2<sup>nd</sup> Qtr.-STF)**. Bids received in excess shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
