 payments under the contract for the SUPPLY AND DELIVERY OF VARIOUS MATERIALS FOR THE REROOFING OF ACADEMIC 1 BUILDING ALLIIS CAMPUS. Bids received in excess shall be automatically
 rejected at bid opening.
- The Carlos Hilado Memorial State College now invites BIDDERS/SUPPLIERS to bid for the SUPPLY AND DELIVERY OF VARIOUS MATERIALS FOR THE RE-ROOFING OF ACADEMIC 1 BUILDING - ALLJIS CAMPUS, as follows:

Delivery of Goods is required within Thirty (30) calendar days upon receipt of Notice to Proceed. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project of at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using the non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
