INVITATION TO BID CHMSC 16-046-1229

- The Carlos Hilado Memorial State College, through the Corporate Budget for the Contract of 2016 approved by
 the governing Board, intends to apply the sum of THIRTY-SEVEN MILLION SIX HUNDRED EIGHTYSIX THOUSAND ONE HUNDRED FOUR PESOS & 00/100 (Php37,686,104.00) ONLY being the
 Approved Budget for the Contract (ABC) to payments under the contract for the PROPOSED
 CONSTRUCTION OF THE TWO (2) STOREY, FOURTEEN (14) CLASSROOMS, ACADEMIC
 BUILDING, CHMSC-BINALBAGAN, NEGROS OCCIDENTAL. Bids received in excess shall be
 automatically rejected at bid opening.
- 2. The Carlos Hilado Memorial State College now invites Bids for the PROPOSED CONSTRUCTION OF THE TWO (2) STOREY, FOURTEEN (14) CLASSROOMS, ACADEMIC BUILDING, CHMSC-BINALBAGAN, NEGROS OCCIDENTAL. Completion of the works is required within 360 calendar days upon receipt of Notice to Proceed. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project of at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using the non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- Bids must be delivered on or before January 24, 2017, 9:30 A.M. at the CHMSC Conference Room, 4/F
 Administration Bldg. Brgy. Zone 1, Mabini St., Talisay City, Negros Occidental. All Bids must be
 accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
- Bid opening shall be on January 24, 2017 at 10:00 A.M. at the same venue and address. Bids will be opened
 in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not
 be accepted.
- The Carlos Hilado Memorial State College reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
