**INVITATION TO BID FOR REPAIR AND ENHANCEMENT OF CONVENTION HALL
(LABOR AND MATERIALS) – BINALBAGAN CAMPUS, BRGY. ENCLARO,

1. The *Carlos Hilado Memorial State College*, through the *Corporate Budget for the Contract of 2017 approved by the governing Board*, intends to apply the sum of **TWO MILLION PESOS & 00/100 (Php 2,000,000.00) ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract for **REPAIR AND ENHANCEMENT OF CONVENTION HALL (LABOR AND MATERIALS) – BINALBAGAN CAMPUS, BRGY. ENCLARO, BINALBAGAN, NEGROS OCCIDENTAL**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Carlos Hilado Memorial State College* now invites bids for **REPAIR AND ENHANCEMENT OF CONVENTION HALL (LABOR AND MATERIALS) – BINALBAGAN CAMPUS, BRGY. ENCLARO, BINALBAGAN, NEGROS OCCIDENTAL** pursuant to the technical specifications indicated in the Terms of Reference to be provided. Completion of the Works is required within **90 calendar days upon receipt of Notice to Proceed**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using the non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the “Government Procurement Reform Act”.
