Processing for the renewal and issuance of Wastewater Discharge Permit by the Department of Environment and Natural Resources Environmental Management Bureau-Region 6 (DENR-EMB R6) pursuant to RA 9275, otherwise known as the "Clean Water Act of 2004", DENR Administrative order (DAO) No. 2003-39 - Article II Wastewater Discharge Permit and DAO No. 2016-08 Water Quality Guidelines and General Effluent Standards of 2016, DAO 2003-27 Self-Monitoring Report System, and DAO No. 2004-36, Hazardous Waste Management. - Self-Monitoring Reports

2. Processing for the renewal and issuance of Permit to Operate (PTO) by DENR-EMB R6 pursuant to RA No.8749 the Clean Air Act (CAA) and DAO 2000-81, the implementing Rules and Regulations (IRR) of the CAA. The PTO application requires the submission of the following documents by the Preparer to DENR-EMB R6 for approval:

- Letter requesting amendment of PTO addressed to EMB Regional Director
- PTO Notarized Application Form
- Engineer's Report for Air Pollution Installation updated based on ammendment (if applicable)
- Geo-tagged photos of each campus

3. Preparation and submission of Compliance Monitoring Reports (CMR) to DENR-EMB R6 Environmental Impact Assessment (EIA) Section on the compliance of general conditions and restrictions stipulated in the ECC of each campus under the Philippine Environmental Impact Statement (EIS) System, as per DAO 2003-27 Self Monitoring Report System.
