All College personnel (regular and temporary) are required to submit Sworn Statement of Assets, Liabilities and Net Worth (SALN) as of December 31, 2017 pursuant to Section 17, Article XI of the 1987 Constitution, Section 8 of RA 7613 (Code of Conduct and Ethical Standards for Public Officials and Employees) and Section 7 of Republic Act 3019 (Anti-Graft and Corrupt Practices Act).

All SALN shall be submitted to the Human Resource Management Office until March 26, 2018 only.

Failure of an officer or employee to submit his/her SALN is a grave offense and is punishable under Section 50, (D) (8), Rule 10 of the 2017 Rules on Administrative Cases in the Civil Service (2017 RACCS), with the following penalties:
