All College personnel (permanent & temporary) are hereby enjoined to submit Sworn Statement of Assets, Liabilities and Net Worth (SALN) as of December 31, 2019 pursuant to Section 17, Article XI of the 1987 Constitution, Section 8 of RA 6713 (Code of Conduct and Ethical Standards for Public Officials and Employees) and Section 7 of Republic Act 3019 (Anti-Graft and Corrupt Practices Act).

The accomplished SALN shall be submitted to the Human Resource Management Office not later than February 28, 2020 and subsequently be submitted to the OMBUDSMAN not later than April 30, 2020 in original and electronic (scanned) copies.

The early submission of SALN is required so that the Committee on Review and Compliance will have ample time to check and review the entries in the SALN and to submit a list to the Office of the College President, copy furnished the Civil Service Commission for the following

- Those who filed their SALNs with complete data; Those who filed their SALNs with incomplete data; and Those who did not file their SALNs.


