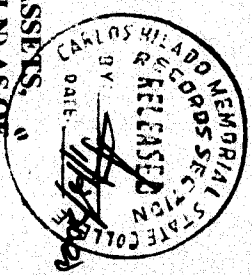

All College personnel (permanent & temporary) are hereby enjoined to submit Sworn **Statement of Assets, Liabilities and Net Worth (SALN) as of December 31, 2019** pursuant to Section 17, Article XI of the 1987 Constitution, Section 8 of RA 6713 (Code of Conduct and Ethical Standards for Public Officials and Employees) and Section 7 of Republic Act 3019 (Anti-Graft and Corrupt Practices Act).

The accomplished SALN shall be submitted to the Human Resource Management Office **not later than February 28, 2020** and subsequently be submitted to the OMBUDSMAN not later than April 30, 2020 in original and electronic (scanned) copies.

The early submission of SALN is required so that the Committee on Review and Compliance will have ample time to check and review the entries in the SALN and to submit a list to the Office of the College President, copy furnished the Civil Service Commission for the following:

1. Those who filed their SALNs with complete data;
2. Those who filed their SALNs with incomplete data; and
3. Those who did not file their SALNs.

Failure of an officer or employee to submit his/her SALN is a less grave offense and is punishable under Section 50, (D) (8), Rule 10 of the 2017 Rules on Administrative Cases in the Civil Service (2017 RACCS), with the following penalties:

- 1st Offense : Suspension of one (1) month and one (1) day to six (6) months
 2nd Offense : Dismissal from the service

Further, SALN is likewise a requirement in the grant of the Performance-Based Bonus (PBB).

Kindly be guided accordingly.

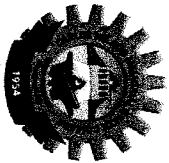

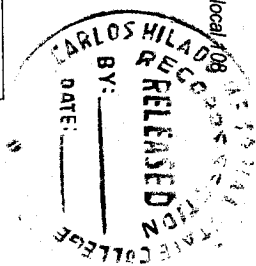


