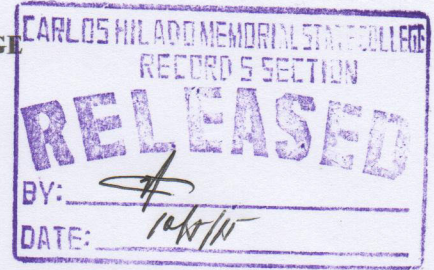

- The *Carlos Hilado Memorial State College*, through the *Corporate Budget for the Contract of 2015 approved by the governing Board*, intends to apply the sum of **TWO MILLION SIX HUNDRED TWENTY-EIGHT THOUSAND & 00/100 (Php 2,628,000.00)** ONLY being the Approved Budget for the Contract (ABC) to payments under the contract for the **SUPPLY AND DELIVERY OF VARIOUS IT EQUIPMENT FOR VARIOUS OFFICES-TALISAY CAMPUS**. Bids received in excess shall be automatically rejected at bid opening.

Delivery of Goods is required within **fifteen (15) calendar days upon receipt of Notice to Proceed**. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project of at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

- Bidding will be conducted through open competitive bidding procedures using the non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

- Bids must be delivered on or before **October 26, 2015, 9:00 A.M.** at the CHMSC Conference Room, 4/F Administration Bldg. Brgy. Zone 1, Mabini St., Talisay City, Negros Occidental. All Bids must be accompanied by a bid security specified in the Bid Data Sheet.
- Bid opening shall be on **October 26, 2015 at 9:30 A.M.**, at the same venue and address. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.
