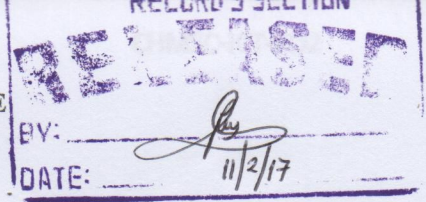

INVITATION TO BID FOR THE PROPOSED MACHINE SHOP TOILET IMPROVEMENT/EXTENSION, PROPOSED RAC AND CIVIL TECHNOLOGY BUILDING SANITARY PIPE LINE RELOCATION, AND RE-PAINTING OF MACHINE SHOP, CIVIL TECHNOLOGY, LSAB LIBRARY AND AUTOMOTIVE BUILDING EXTERIOR WALLS (LABOR AND MATERIALS) – TALISAY CAMPUS

1. The *Carlos Hilado Memorial State College*, through the *Corporate Budget for the Contract of 2017 approved by the governing Board*, intends to apply the sum of **SIX HUNDRED NINE THOUSAND ONE HUNDRED EIGHTY-FIVE PESOS & 00/100 (Php 609,185.00) ONLY**, being the Approved Budget for the Contract (ABC) to payments under the contract for the **PROPOSED MACHINE SHOP TOILET IMPROVEMENT/EXTENSION, PROPOSED RAC AND CIVIL TECHNOLOGY BUILDING SANITARY PIPE LINE RELOCATION, AND RE-PAINTING OF MACHINE SHOP, CIVIL TECHNOLOGY, LSAB LIBRARY AND AUTOMOTIVE BUILDING EXTERIOR WALLS (LABOR AND MATERIALS) – TALISAY CAMPUS**. Bids received in excess shall be automatically rejected at bid opening.
2. The *Carlos Hilado Memorial State College* now invites bids for **PROPOSED MACHINE SHOP TOILET IMPROVEMENT/EXTENSION, PROPOSED RAC AND CIVIL TECHNOLOGY BUILDING SANITARY PIPE LINE RELOCATION, AND RE-PAINTING OF MACHINE SHOP, CIVIL TECHNOLOGY, LSAB LIBRARY AND AUTOMOTIVE BUILDING EXTERIOR WALLS (LABOR AND MATERIALS) – TALISAY CAMPUS**, as follows:

ONE (1) LOT VARIOUS PROJECTS (LABOR AND MATERIALS) Php 609,185.00

Delivery of Goods is required within **Twenty (80) calendar days upon receipt of Notice to Proceed**. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project of at least 50% of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using the non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from CARLOS HILADO MEMORIAL STATE COLLEGE and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M.

A complete set of Bidding Documents may be acquired by interested Bidders on **November 1 – November 8, 2017** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of One Thousand Pesos (**Php 1,000.00**) Only.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the CARLOS HILADO MEMORIAL STATE COLLEGE, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The CHMSC will not hold a pre-bid conference for this project.
7. Bids must be duly received by the BAC Secretariat at the **CHMSC Conference Room, 4/F Administration Bldg., Brgy. Zone 1, Mabini St., Talisay City, Negros Occidental** on or before **11:00 A.M., November 9, 2017**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **11:30 A.M., November 9, 2017**, at the same venue and address. Bids will be opened in the presence of the bidders' representatives who choose to attend at the **CHMSC Conference Room, 4/F Administration Bldg., Brgy. Zone 1, Mabini St., Talisay City, Negros Occidental**. Late bids shall not be accepted.

The Carlos Hilado Memorial State College reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
