ANNOUNCEMENT !!!

Pursuant to RA 8292, the Board of Regents of **CARLOS HILADO MEMORIAL STATE UNIVERSITY (CHMSU)**, formally and publicly announces that the **Positions for Two (2) Members of the Board of Regents representing the PRIVATE SECTOR are now open.**

- A. **MINIMUM ELIGIBILITY REQUIREMENTS** Applicants / Nominees for PSR to the Carlos Hilado Memorial State University (CHMSU) Board of Regents (BOR) must meet the following minimum eligibility requirements:
 - 1. Must be a Filipino citizen and of legal age;
 - 2. Must be from an industry, business, or profession preferably related to the CHMSU's charter or mandate;
 - 3. Must have at least five (5) years of employment, business, or practice of profession in the private sector;
 - 4. Must be a resident for at least two (2) years of the city or province where CHMSU or its campuses are located;
 - 5. Must not be connected with CHMSU or other government agencies and instrumentalities in any manner, for one (1) year immediately prior to his or her application / nomination to the Private Sector Representative (PSR) position;
 - 6. Must not be currently employed or appointed to any position in the government (local, national, including government-owned and controlled corporations), be it full time or part time, at the time of application / nomination for the Private Sector Representative (PSR) position;
 - 7. Must not be related to any member of the present Board or their duly authorized representatives, within fourth civil degree of consanguinity or affinity; and,
 - 8. Must not have been a candidate who lost in any national or local election, except for barangay elections, within one (1) year after such election.
- **B. DOCUMENTARY REQUIREMENTS** Nominators/Nominees/Applicants for the position of the Private Sector Representative (PSR) shall provide the following documentary requirements:
 - 1. Duly notarized application or nomination (with the conforme of the applicant /nominee); Formal Application / Nomination Letter addressed to:

- 3. Certificate of Employment stating the applicant / nominee present position in the private sector related to the industry, business or profession related to the CHMSU's charter or mandate;
- 4. Service Record of the applicant / nominee who has been employed in the government at any point;
- 5. Latest NBI Clearance;
- 6. Certification that applicant / nominee is not connected with CHMSU;
- 7. Signed Commitment and Availability of the applicant / nominee to serve as PSR;
- 8. Signed Conforme to the conditions of PSR; and
- 9. Other documents as may be required by the CHMSU Board of Regents.

Applications, nominations, and other documentary requirements shall be filed personally, through a representative, by registered mail, or by authorized private courier. All applications or nominations must be received not later than <u>July 23, 2025, at 5:00</u> <u>p.m.</u>, if mailed, it must be postmarked <u>July 23, 2025</u>. Online submission of documents may be allowed subject to submission of hard copies of the same.
